WILLIAM WERSCHLER CAN TESTIFY TO THE FOLLOWING: He and Kara are married and have children in common. They are in the process of a divorce and live at different locations. On 10-28-05 he picked up their son John from school then went to 4114 S Lloyd to pick up his daughter for his scheduled visitation. John went inside to get his sister only to come running out of the house with Kara behind him. Kara grabs Johns arm and pins him against William's car. William tells her to stop. William then starts to dial his attorney when Kara grabs his phone and shoves it in his face causing him to get scratched and cuts inside his mouth.

J. WERSCHLER CAN TESTIFY TO THE FOLLOWING: He is the son of William and Kara Werschler. On 10-28-05 his dad William picked him up from school. They went to his mom's Kara to pick up his sister. He went inside to get her. He yelled for his mom Kara she got mad at him for yelling. He ran outside to his dad. His mom followed grabbed his arm, shook him and pinned him up against the car. His dad William told her to stop. Kara yelled at William and pushed his cell phone into his face. He stated his arm hurt. William has a scratch on his cheek.

DEPUTY D.WELLS CAN TESTIFY TO THE FOLLOWING: He is a deputy for Spokane County Sheriff's Office. He was on duty 10-28-06. He was dispatched to 20706 W Salnave for a domestic violence report. He contacted William and J. Werschler. Deputy Wells observed a small cut the width of a finger on the outside of William's left cheek. He looked inside the mouth of William and saw a bruise about an inch in diameter by 1/2 inch. Deputy Wells did not see any marks on John's arm.

DEPUTY NORTH JONES CAN TESTIFY TO THE FOLLOWING: She is a Deputy for Spokane County Sheriff's Office assigned to the Spokane Regional Domestic Violence Team. She reviewed the case on 07/07/06. She prepared the affidavit of probable Cause.
